

## Pro-Lifers Keep PP Abortions out of Luverne, Minn!

At the last minute, Planned Parenthood of North Central States (PPNCS) was halted in its efforts to open a “telemed” chemical abortion center in Luverne, Minn. (population 4,745). This victory was the result of the research and coordination of Pro-Life Action Ministries and the efforts of the strong pro-life community in the tri-state region surrounding Luverne.

Luverne is located about 40 miles east of Sioux Falls, S.D. where PPNCS (based in St. Paul, Minn.) operates an abortion mill, with the abortionists traveling there from St. Paul. However, this abortion center has not been doing abortions since late March, according to Sara Beaner, the Sidewalk Advocates for Life Program Director in Sioux Falls. Apparently, it is closed due to the COVID-19 pandemic, although the specific reasons are unknown. Perhaps the St. Paul abortionists are unwilling to travel there?

In mid-April, Pro-Life Action Min-

istries learned that PPNCS was scheduling chemical abortions (the abortion pill) in Luverne beginning on Monday, April 20. The plan was to have the abortion client at the leased office on Main St. in Luverne speak with an abortionist at the PPNCS headquarters in St. Paul via webcam and then take the first of the two drugs used in the chemical abortion procedure. This drug is meant to kill the baby and then the woman would take the second drug at home up to 48 hours later to expel the baby. “Telemed” abortions are illegal in South Dakota, which explains why PPNCS chose a nearby location in rural Minnesota. It already does “telemed” abortions in Rochester, Minn. (see page 4).

Pro-Life Action Ministries quickly alerted its supporters to this urgent situation and asked them to contact the mayor and city council. Mayor Patrick Baustian called Brian Gibson, Executive Director of Pro-Life Action Ministries, after being overwhelmed with messages from concerned citizens. He said he would look into the situation. The owners of the

property, Cary and Karen Radisewitz, confirmed they were leasing to PPNCS (the abortion mill was to move in over the weekend). Also, the two other tenants in the building were caught completely unawares by all this. Because we had included the address and a photo of the building in our original e-mail to supporters, these two businesses were inundated with calls and took up the issue with the owners.

By 2:00 p.m. on Friday, April 24, the owners had terminated the lease with PPNCS. Mr. Radisewitz was quoted in a local news outlet, “Planned Parenthood has never operated in our building, isn’t now and won’t in the future.” This was a very interesting way to spin his involvement, but it was confirmation that PPNCS was not moving in.

We pray that the women who had abortions scheduled in Luverne have chosen life for their children! To the best of our knowledge, the Sioux Falls PP is referring callers to abortion centers in St. Paul,

As I walked up to the “For Sale” sign with Amber, my friend and fellow sidewalk counselor, in front of the former EPOC abortuary owned by the infamous late-term abortionist James Pendergraft, I was filled with tears of joy. My thoughts immediately drifted to all the Christians who, for almost 20 years, had been there to be a voice for the voiceless, pleading for the lives of innocent little baby boys and girls.

My mind then drifted to all who had prayed over the years for this abortuary to be shut down, along with the other four

# The Hardest Sidewalk Counseling Situation for Me

Recently, during one of my regular Wednesday sidewalk counseling times at the mega-Planned Parenthood (PP) in St. Paul, Minn., I experienced the most difficult situation I've ever had.

A woman, alone in her vehicle, stopped to take the literature I was offering. She expressed gratitude in receiving the "We're Here for You" brochure and the "blue sheet" that lists all the places help is available for a pregnant woman. She told me that it was of God that I was there and that she was receiving information she needed. She went on to tell me that she had two young children and that she really didn't want an abortion, but her boyfriend and the coronavirus shut-down was pushing her to abort.

I quickly picked up on what she was so readily telling me and started to make her baby as human to her as possible, letting her know she had three children and that her unborn child would be gorgeous and precious to her. As she agreed with me, I began to press for her to go directly to Abria, the nearby pregnancy resource clinic. She balked for a moment, telling me she had an appointment with PP and indicating an obligation to show up for that appointment. I let her know that many women fail to show up for these appointments and it doesn't faze PP in the least.

I am not giving you all the details of what became a five minute conversation, but suffice it to say I believed in my mind and heart, because of the interaction and the responses I was receiving from her, that this was going to be a baby saved. She even told me her name, something that we usually only get when the woman has decided not to abort and to accept our help. I just needed to get her out of there and to not go into PP.

Then there was one last thing – she said she was going to call her boyfriend.

Before I could start to respond to that, the security guard from PP started telling her to move out of the driveway. I told her to just turn around and come right back out, I had more I needed to tell her. Instead, she took a parking spot in the area where many of the abortion clients park. I prayed that she was reading the materials I had given her and that she would just drive out. She just sat there for the longest time.

Then my heart sank when she stepped out of her car to walk into PP. She called out to me something I could not hear. The one thing I did hear was her saying she was sorry, a clear indicator that she was going in for the abortion. Apparently, she had been on the phone with her boyfriend and he had said enough to push her to abort their baby.

About a half hour later she came back out. Another five-plus minute conversation with her as she went to get a smoke. I pressed her to not come back and

instead of PP, go to Abria after the cigarette. About 20 minutes later, she returned with a friend in the car. Again another five minute conversation. This time I asked if I could pray with her with her knowing I would be praying that she not have the abortion. She said yes. I did. But she still had the abortion.

It would have been easier to be called a name, flipped off or just receive the cold indifference that we so often get from those coming for abortions. This was hard because of the emotional investment that came with the conversations and the reasonable hope that this woman and her child could be saved from abortion.

Sidewalk counseling can be very draining and difficult. Yet, scores of volunteers take the time to be present and endure the difficulties each week to do all they can to save lives. Please pray for our sidewalk counselors, not only for success but also for the encouragement and strength from God to keep up this vital life-saving work. Pray and consider taking up one of the most challenging ministries in America.

Rochester, and Omaha, Neb., each of which is about 200 miles (or more) from Sioux Falls.

### Look out southwestern Minnesota and northwestern Iowa

“We thank the good people of Luverne and the surrounding region for their quick action in keeping a killing center out of their area,” said Gibson. “We strongly suspect that PPNCs, having failed to open up in Luverne, will be scouring for another location to commit these abortions. If you know people in the area, encourage them to keep a diligent lookout for this possibility in their town. Do they know property owners in their area who are Planned Parenthood supporters? It is far easier to stop Planned Parenthood from coming in than to get them out once established.”

## Lawsuit Filed to Stop Surgical Abortions in Minnesota During Pandemic

Although Minnesota Governor Tim Walz recently lifted his ban on non-essential, elective surgeries and procedures, a lawsuit that Pro-Life Action Ministries is involved in is still in the courts for now. On April 28, the Thomas More Society sued the state’s abortion providers on behalf of a coalition of doctors and Minnesota residents to stop them from committing surgical abortions during the COVID-19 pandemic. The complaint names Gov. Walz, Commissioner of the Minnesota Department of Health Jan Malcolm, and each of Minnesota’s four abortion providers as defendants. The plaintiffs include doctors, nurses, the AALFA Family Clinic, the American Association of Pro-Life Obstetricians and Gynecologists, Pro-Life Action Ministries, and several concerned individuals.

The Minnesota Department of Health had refused to enforce the governor’s order against abortion providers. In fact, the governor had specifically exempted abortion providers from the rules that all other health-care providers were required to follow.

The lawsuit asked the court to declare that Walz, Malcolm, and the state’s abortion facilities violated the Equal Protection Clause by exempting abortion providers from Minnesota’s COVID-19 prevention measures. The complaint also requested that Walz and Malcolm be enjoined from enforcing their COVID-19 executive orders “unless and until those orders are amended or reinterpreted to prohibit surgical abortions.”

If this lawsuit goes forward under the changed circumstances, we will keep you informed of developments.

do exceedingly, abundantly, above all that we ask or think, according to the power that works in us.”

mills owned by Pendergraft. Never giving up, continually praying, being there as a witness to the evil taking place inside of these killing centers, and rescuing those unjustly sentenced to death. *Praying that the Pendergraft abortion empire would crumble!*

And then it began. In 2015, abortionist Pendergraft was arrested as the result of a traffic stop in South Carolina. In his vehicle, police found bloodied surgical equipment covered with human tissue from abortions he had been committing illegally. He was also in possession of illegal narcotics. The sheriff on this case labeled him the “*traveling abortionist*”!

In 2016, Pendergraft’s Ocala, Fla., abortuary shut down, and was sold! Miraculously, by the grace of God, it opened up as an Interfaith Emergency Service, helping the homeless with medical/dental services and helping them get off the street!

One year later, in October of 2017, Pendergraft pleaded guilty to the charges brought against him when arrested in South Carolina and he was sentenced to five years probation and over \$26,000 in fines (which in our opinion, was certainly not enough)!

At this time his medical license had been suspended five times, and soon aft-

## New Billboard Near PP in Rochester, MN!



Through the hard work of local pro-lifers, this new billboard was posted in mid-May across the street from the Planned Parenthood (PP) abortion center in Rochester, Minn.! Abortions via the abortion pill are committed there on Mondays. We hope and pray that many lives will be saved when women see this sign, even if they’ve already taken the first pill of the two-drug procedure. A nationwide network of pro-life health professionals working with Abortion Pill Rescue (the organization that manages the abortion pill reversal program) has been successful in about 68% of reversal cases, resulting in nearly 1000 lives saved so far! er, it was suspended a sixth time. Finally, his medical license was revoked in December of 2018! I was able to attend the Florida Board of Medicine hearing with Cheryl Sullenger of Operation Rescue, and when we heard them declare that his medical license was revoked, we wanted to shout for joy that finally he was being held accountable, and would be stopped

in the state of Florida from killing little baby boys and girls! Finally, after all these years of botched abortions, and thousands upon thousands of babies who died brutal and horrendous deaths!

That same year, the EPOC abortion business shut down and we thanked the Lord God Almighty! For the next two years the building was used on and off as a medicinal marijuana dispensary.

Soon after, Pendergraft filed bankruptcy on his three remaining abortuaries in Tampa, Fort Lauderdale and Orlando (OWC). And now, during such a time as this, in April “For Sale” signs went up at the Fort Lauderdale mill, which had already been shut down for a few weeks, and then the Tampa mill shut down, and a “For Sale” sign was subsequently put up, along with the sign at the closed EPOC abortuary!

The OWC abortuary is the only remaining Pendergraft mill still open, and it is under bankruptcy as well as the others. We are praying that God would shut that wicked place down as well!

We continue to pray that the James Pendergraft abortion empire would completely crumble! Wickedness can only go so far before the Lord sheds HIS light on it and ends it, according to my friend Amber! And most certainly that is what

The mama was weeping while we prayed, and the daddy began to weep, and the Lord swept down and miraculously put a love in their hearts for their baby and a sorrow

Jessika Ralph, MD, 33, is the medical director of Whole Woman's abortion mill in Bloomington, Minn. (formerly located in Minneapolis). She is also an assistant professor in the Department of Obstetrics, Gynecology and Women's Health at M Health Fairview. Ralph completed the "Family Planning Fellowship" abortion-training program at Northwestern University School of Medicine in Chicago.

On February 27, Ralph testified in the Minnesota House Judiciary Committee in favor of a bill that would have restricted sidewalk counseling. (It never went any further in this legislative session.)

Then (according to a March 11, 2020 article in *The Minnesota Sun*), when Minneapolis Mayor Jacob Frey named March 10 as "Abortion Providers Appreciation Day," Ralph said, "When our elected officials recognize the work we do as providers to deliver abortion care, our communities are healthier and safer. We are so grateful to Mayor Frey for recognizing Whole Woman's Health, and for all the work his administration has done to support reproductive health care access in Minneapolis."

Please pray that Ralph would stop killing unborn children, repent, turn her life over to Christ, and spend the rest of her medical career *saving* lives.

All these methods (and others) can cause very early abortions by thinning the lining of the uterus so that if breakthrough ovulation occurs (which is possible) and a new life is conceived, the young human being may not be able to attach to the uterine lining and therefore he or she dies. These methods can also be very dangerous, even deadly, to the woman.
