

PP Expands Abortions to Brooklyn Park, Minn.



Planned Parenthood (PP) has started killing unborn children up to 11 weeks via chemical abortion (the “abortion pill”) at its new location on Brooklyn Boulevard in Brooklyn Park. The woman never sees a physician in person; instead, she speaks with an abortionist located at the St. Paul PP via video (as is also the case with the Rochester, Minn. PP). The Brooklyn Park PP had been located in a nearby office park before it moved to this much more visible location in late May. Up to this time, it was an abortion referral and birth control center but did not commit abortions.

More than 50 people attended our first prayer rally outside this new abortion site on July 24. Brian Walker, Program Director of Pro-Life Action Ministries, led the rally, assisted by Pastors Rick Ensrud, Mark Ellingson and Yonas Hailu. Vicki Olson, a regular prayer supporter, encouraged the attendees to continue praying outside abortion centers. Many passersby (and shoppers at Aldi next door) were supportive of our efforts. We need sidewalk counselors and prayer supporters at this new location on Fridays (mornings and afternoons). 2019 Minnesota Abortion Statistics Released

Planned Parenthood continues to dominate the Minnesota abortion industry by increasing both the number of children it kills and the share of abortions committed, according to statistics released by the Minnesota Department of Health (MDH) on July 1. PP now commits 65% of the abortions in the state. Since moving into its “mega-mill” on Vandalia St. in St. Paul in late 2011, PP’s annual abortion numbers have jumped 79%.

This follows the national trend in PP’s increasing share of abortions. Meanwhile, PP’s non-abortion clients have dropped dramatically in recent years. Not surprisingly, the new president and CEO of the Planned Parenthood Federation of America, Alexis McGill Johnson, is

described by PP as “a social and racial justice leader, lifelong political and cultural organizer, and a tireless advocate for reproductive rights,” NOT as a healthcare

leader.

Overall, there were 9,922 abortions

President Trump's Many Pro-Life Accomplishments

President Donald Trump is widely recognized as the most pro-life U.S. president in history. He has also done much to protect religious liberty.

As President, Mr. Trump has:

- * Signed a bill that allowed states to defund Planned Parenthood of Title X (family planning) funding, reversing an Obama attempt to force states to fund abortion providers.
- * Reversed an Obama Administration policy that blocked states from deciding if Planned Parenthood should be stripped of Medicaid funding.
- * Finalized the Protect Life Rule, cutting Planned Parenthood's federal funding by \$60 million.
- * Reinstated the Mexico City Policy that ends federal funding of overseas abortions. The Protecting Life in Global Health Assistance program safeguards more than \$8.8 BILLION in overseas aid from being used for abortions.
- * Defunded the United Nations Population Fund (UNFPA) which supported China's population control program (which includes forced abortions).
- * Appointed 200 federal judges (so far) – including two Supreme Court justices – who uphold the pro-life view that all life



is sacred from the moment of conception.

- * Urged Congress to vote to protect innocent human life by asking members to pass the following bills:

Born-Alive Abortion Survivors Protection Act

- * Issued new guidance ensuring hospitals provide medical care to infants who survive abortions
- * Proposed numerous resolutions to fight Obama-era pro-abortion policies:
 - Require Obamacare insurers to issue separate invoices for abortion coverage.
 - Require Obamacare insurers to provide clients an identical plan in the same geo-

graphic area that does not provide coverage of abortion.

Reverse the Obama policy that made recipients of certain federal funding provide abortions.

- * Taken the pro-life movement to the world stage: The administration opposes the efforts of the United Nations to make abortion an international human right.
- * Taken steps to protect pro-life organizations from having to provide abortion referrals or cover abortion in their health insurance plans.
- * Spoken in person at the 2020 National March for Life
- * Proclaimed January 22, 2020 as National Sanctity of Human Life Day.

* The Department of Health and Human Services (HHS) has dramatically shifted in placing value on the unborn:

Funding for fetal tissue research — which uses aborted human body parts — has been cut.

HHS' newly created Conscience and Religious Freedom Division fights for doctors, nurses, and other health care professionals who do not wish to have any part in abortions.

The Trump-Pence administration is protecting all Americans' First Amendment rights.

Pregnant Mom's Questioning of Doctor Saves Baby!

On June 21, 2019, at 6.5 weeks pregnant, I was rushed to the emergency room at United Hospital for emergency surgery for an ectopic pregnancy. I had experienced some bleeding and mild cramping the day before, leading me to have an ultrasound performed to see if the baby was okay or if I was experiencing an unfortunate miscarriage. I cried tears of joy when the ultrasound technician showed me my sweet baby's heartbeat. I was so relieved...until I received the radiologist's report minutes later. I was told, "The baby is unfortunately not growing in your uterus, but between your uterus and fallopian tube. There is no chance of survival. Your life is at risk, too, in case of rupture. We are recommending emergency surgery tonight."

I don't think I've ever cried so hard in my life. Here, I had just seen my sweet baby's little heart beating after I thought I was losing him. Now, I was told that although my baby was okay for now, he would no longer be alive at the end of the night after this emergency procedure.

Once I got to the emergency room and was all checked in, I met with the sur-

geon. She stated that because of the baby's location, it was also likely that they would have to remove a significant portion of my uterus, fallopian tube, and ovary. She said it was unlikely that I would be able to deliver a baby naturally again.

Heartbroken in so many ways, my whole family and I began praying for a miracle.

The nurses continued preparing me for surgery, drawing significant amounts of

blood in case I would need a blood transfusion after surgery. I was told it was highly likely considering the type of procedure I was about to undergo.

When the surgeon came back in, she said to the nurse that she was able to see the written report from my ultrasound earlier that day, but due to a glitch in the computer system, she was unable to pull up the images. She said she would proceed with the surgery anyway.

This is when a glimmer of hope rose up in me as I thought to ask for a second opinion. I explained to the surgeon that I did not feel comfortable with her operating on me if she was not able to see images of what she would be operating on. I also wanted a second ultrasound to confirm that the surgery was, in fact, necessary.

She was angry that I was questioning her, but eventually she gave in and ordered a second ultrasound.

What happened next was nothing short of a miracle. My emergency room doctor came in with tears in her eyes and a smile on her face. She said, "Baby is growing in the right location. There's no need for surgery today. You can go home now."

Today Isaac is a healthy 6-month-old boy. His life is truly a miracle. I tear up when I think of the day I almost lost him. This reminds me of the importance of getting a second opinion whenever an issue during pregnancy is found. It could be life-saving.

Robbinsdale Prayer Group Helps Save Baby!

While I was sidewalk counseling one

morning in mid-June outside the Robbinsdale abortion center, I noticed a woman sitting in her vehicle nearby, so I offered her literature through the open passenger window and asked if she was waiting for someone inside the abortion center. No, she said, she was waiting for a friend in the nearby apartment building. But she was happy to talk to me because she wanted to let us know that her cousin had chosen life for her unborn baby after calling the number on our “We’re Here” brochure and finding out about the resources available. Go back to earlier in the month when this woman had seen

people praying and sidewalk counseling outside the Robbinsdale abortion center. She walked over to them, explained that her cousin was considering abortion and that she was trying to persuade her not to do that. Long-time volunteer sidewalk counselor Judi S. gave her literature and spoke with her. Then Judi introduced her to Brian Gibson, as the leader of Pro-Life Action Ministries, who could also help her cousin. Fr. Tom Dufner was also there, having just finished leading the Rosary group as he has on Saturday mornings for decades. Both Brian and Fr. Dufner encouraged the cousin in her desire to save the baby’s life. I was thrilled that I had the privilege of learning “the rest of the story,” ten days later!

reported in Minnesota in 2019, which is 12 more than in 2018 (see chart at right). The number of abortions has basically remained steady the last several years, after falling for seven years in a row from 2006 to 2013. (The other abortion mills in Minnesota committed more abortions in 2019 due to the November 2018 closing of the Mildred Hanson abortion center in Minneapolis.)

According to an analysis by Minnesota Citizens Concerned for Life (MCCL), Minnesota abortions have fallen 48% since peaking in 1980. The abortion rate (abortions per 1,000 Minnesota women of reproductive age) was an estimated 8.4 in 2019. With the help of the state’s 1981 parental notification law, abortions on minors dropped from 2,327 in 1980 to 259 in 2019.

Chemical abortions (the “abortion pill”) comprised about 37% of the state abortion total. Of its total number of abortions (including the 182 chemical abortions at the PP in Rochester), PP committed the greatest percentage of chemical abortions — about 41%, with Whole Woman’s (WW) next at 38%.

(Sidewalk counselors, please be aware of the large number of abortion clients who would benefit from hearing about abortion pill reversal so their babies

Following are some of the reasons women gave for their abortions in 2019 (more than one reason could be given and some women refused to answer):

- * 68% “does not want children at this time”
- * 21% economic reasons
- * Less than 2% for “fetal anomalies”
- * Less than 1% for rape or incest
- * Less than 1% because the pregnancy could “cause impairment of major bodily function” of the mother

TOTAL 9,922

About 60% of the abortion clients had at least one other child. About 39% had undergone one or more previous abortions; a total of 704 women had undergone three or more previous abortions, with 22 of those reporting 9 or more previous abortions.

Blacks were disproportionately represented in the abortion numbers. They comprise a little more than 6% of Minnesota’s population, but accounted for nearly 30% of the abortions on Minnesota residents. At the Robbinsdale abortion center, more black children were killed than white children. The largest numbers of Hispanic babies killed were at PP and Whole Woman’s, comprising

was going to PP to have an abortion. She told me yes. I asked if I could share with her some information and gave her the pamphlet of resources available. She shared with me much information regarding the fear and uncertainty about her unexpected pregnancy. She said my being there was a sign to not go through with the abortion and also that her young son was excited about having a baby brother (the surprising thing was that she had not told him about her pregnancy... also a sign from God to keep her baby). As we spoke she shared how proud she is of her son and that she knows he would be a great big brother to this child. She told me she never had an abortion before and was very scared how this would

affect her spirit. She also shared that some of her friends who have had an abortion are not the same and are more bitter and angry. I told her that I have heard others share this same experience after an abortion. I told her about Abria (the nearby pregnancy center) and the wonderful supports available to pregnant women. After about 30 minutes she told me she was definitely keeping this baby and showed me her belly, telling me she was about 2 months along. She could already feel the baby moving and told me she could do this (have the baby). We walked to the bus stop together. Please keep this beautiful young lady and her growing family in your prayers.

Is Your Doctor Involved in Abortions?

Does Your Doctor Prescribe Abortifacient Birth Control?

Ask your doctor if he/she does abortions or refers for them, or prescribes abortifacients such as the Pill, Ortho Evra (the "patch"), Depo-Provera (the "shot"), Nuva-Ring, the "morning-after pill," implants, or the IUD. All these methods (and others) can cause very early abortions by thinning the lining of the uterus so that if breakthrough ovulation occurs (which is possible) and a new life is conceived, the young human being may not be able to attach to the uterine lining and therefore he or she dies. about 11% and 9% of the abortions respectively.

Although gestational age was not reported for 141 abortions, the latest abortion reported was at 30 weeks, with 178 between 21 and 25 weeks (when survival outside the womb is possible). Three abortions resulting in a born-alive infant were reported. Presumably these were reported by hospitals killing special-needs babies. It is extremely unlikely that the abortion mills that do late-term abortions (PP and Whole Woman's), would report any live births (although required to since July 2015), particularly if they illegally kill abortion survivors or traffic in aborted baby parts. (See our website, www.plam.org, for documentation of these practices.)

Quoting from the Minnesota abortion report regarding the three born-alive infants in 2019: "In one instance, fetal anomalies were reported but residual cardiac activity was present at 2 minutes. Care of fetus was transferred to the second medical doctor. No measures taken to preserve life were reported and the infant did not survive. In one instance, comfort care measures were provided as planned and the infant did not survive. In one instance, the infant was previable. No measures taken to preserve life were reported and the infant did not survive."

Nearly 659,000 unborn babies have been killed in Minnesota since the 1973 *Roe v. Wade* decision.

The average number of babies killed at each Minnesota location *per abortion day* in 2019 were:

Planned Parenthood – 21
Whole Woman's – 9
Duluth - 9
Robbinsdale - 5
Rochester PP - 4
