Reducing Physical and Legal Risks on the Sidewalk

Throughout the centuries, Christians have been persecuted for sharing the Gospel and attempting to do good. It is no different for those of us in the pro-life movement. But even though Pro-Life Action Ministries' staff and volunteers have logged hundreds of thousands of hours on the sidewalks since 1981, we have experienced relatively few frightening incidents. And even following the Dobbs decision, things have remained relatively calm on the sidewalks. But due to recent incidents involving the FBI, this is a good time to remind you of ways to try to reduce physical and legal risks while you are sidewalk counseling or praying outside abortion mills.

A sidewalk counselor in Philadelphia, Mark Houck, was recently arrested by multiple, heavily armed FBI agents in front of his wife and seven children, and charged with violating the federal FACE (Freedom of Access to Clinic Entrances) Act. Shortly thereafter, two FBI agents questioned a prayer supporter outside the Planned Parenthood (PP) in St. Paul.

To date, 23 pro-lifers have been arrested this year by the FBI or indicted by Biden's Department of Justice (DOJ), most due to participating in previous "rescues" at abortion centers in Tennessee or Washington, D.C. (where 115 aborted babies were retrieved this past March, including 5 late-term babies that may have been illegally killed). During these rescues, the pro-lifers peacefully blocked the entrances and/or entered the abortion centers to pray, sing and offer life-saving help to the abortion clients.

According to reports, if the pro-life activists are convicted of the FACE allegations, those charged with conspiracy could spend up to 11 years in prison and be fined up to \$260,000, while the others face up to a year in prison and fines up to \$10,000.

Mark Houck's case stemmed from an incident in 2021 in which he pushed a long-time abortion escort away from his

12-year-old son whom the escort was verbally abusing with vile comments. In St. Paul, the prayer supporter questioned had pushed a woman who had used a box-cutter to partially destroy a pro-life sign and was after the sign again. In these two cases, state criminal charges had all been dismissed against the pro-lifers before the FBI got involved. (The prayer supporter in St. Paul was NOT arrested by the FBI.)

The actions of the DOJ and the FBI in these cases are wildly disproportionate to the allegations and are seen by many as a political move by the Biden administration against people who oppose abortion. The federal FACE Act prohibits actions which "by force or threat of force or by physical obstruction, intentionally injures, intimidates or interferes with or attempts to injure, intimidate or interfere with any person because that person is or has been . . . obtaining or providing reproductive health services." The FACE Act also prohibits action which "intentionally damages or destroys the property of a facility, or attempts to do so, because such facility provides reproductive health services, or intentionally damages or destroys the property of a place of religious worship" and yet at least 160 prolife pregnancy centers and churches have been vandalized or firebombed since May and no FBI arrests have been made in those cases.

We should NOT be intimidated by the government's current actions. The FACE Act does NOT prohibit First Amendment activities such as sidewalk counseling, picketing or praying outside abortion centers. But to help protect yourself and others, we ask you to adhere to the following:

 While you are praying or sidewalk counseling, do not physically impede those entering or leaving the abortion mill. Sidewalk counselors have the First Amendment right to approach cars and pedestrians and to offer literature. People entering or leaving have the right to either accept or reject the literature and the right to stop and talk. Do not touch people or cars. (Some locations have ordinances that may somewhat regulate activity outside certain abortion mills; check with the local leaders of your sidewalk counseling organization.)

- Look around, be aware of what's happening at all times, and don't get caught up in idle chatter. (Actually, this is very important for sidewalk counseling itself so that you do not miss any abortion clients and so that you can keep spiritually focused.)
- Have your cell phone turned on and ready to videotape for legal purposes (and even just to calm down an aggressor). This is particularly important if you are a prayer supporter because the sidewalk counselors should be focusing on the abortion clients. Practice videotaping so that you are prepared to capture an incident at a moment's notice. Just videotape, do not narrate the incident. (If you are capturing an ambulance incident, stay out of the way of the paramedics.)
- If someone acts threateningly towards you (even if you don't particularly feel threatened), defend yourself by walking away and calling 911. Do not push or even touch the person. Clearly describe the incident to the dispatcher and ask for an officer to come to the scene. If the person is inside the abortion mill or in the vicinity, tell the dispatcher that the person is still there. If the person has left, tell the dispatcher that you are concerned that the person might return. Give the dispatcher the license plate number of the threatening person and try to get a photo, or at least a description, of the person. (This is important in case the driver is not the owner of the vehicle.) Then contact your local leaders. (You have a right to exer-

cise your First Amendment liberties without aggression or undue interference. Remember, St. Paul used his rights as a Roman citizen to defend himself and his ministry. By calling 911, you are protecting not only yourself, but other sidewalk counselors and prayer supporters, and overall, your whole sidewalk counseling program and the lives you are trying to save.)

- If someone tries to steal your property, hold onto it firmly, but don't get into a physical struggle over it or you may be charged with assault. Calmly tell the person that he or she is on camera (perhaps even on the abortion mill's cameras), you have the license plate number (if applicable), and a police report will be filed. (You may be able to file such a report on-
- · If you are being accused in an incident, you do not have to give any information to a law enforcement agent (either FBI or local) without an attorney present. You can respectfully ask the officer for a business card and state that your attorney will be contacting him or her. Then contact your local pro-life leaders for legal assistance.
- · If someone throws something suspicious towards you, don't touch it. Call 911.
- · It is less likely that a person would cause trouble if there is a witness or two. Consider asking a friend or family member to go with you to pray and/or hold a sign if it looks as if you will be alone on the sidewalk.
- · Write up an incident report as soon as you can while the details are still fresh in your mind and send it to your local leaders. Include the names of any witnesses.
- If a stranger offers you drinks or snacks, just politely thank them and decline.
- · You are NOT obligated to talk to any passersby if you prefer not to, even if they try to engage you in a conversation. Obviously, it is good to share the pro-life message, but sometimes pro-abortion people can bait you into a discussion,

which can then escalate into a fruitless argument and distract you from your purpose on the sidewalk. On a related note, if another sidewalk counselor has developed a good rapport with someone, do not insert yourself into the conversation unless invited!

· If a media person approaches you, ask for a business card. Even with that verification, you do not have to do an interview. But if you want to, explain that you are there to save lives, help pregnant women and pray. But, again, remember not to get distracted from your purpose of saving lives. Anything beyond these simple comments can be handled by your local pro-life leaders. Refer reporters to them for an official statement on current events. If the reporter or camera-person asks if you want to put a recording microphone on while you are sidewalk counseling, please decline. You don't want to do anything that discourages women from speaking with you and as you know, these conversations can become very personal, not something the woman would want

aired on the evening news! Since you are in a public place, the media have the right to take photographs or videotape you, but you can decline to identify your-

• Do not talk about personal matters (especially identifying information) regarding yourself, other pro-lifers or the pregnant women you meet within earshot of abortion workers, escorts or pro-abortion demonstrators.

Finally, these words of Jesus apply to our ministry on the sidewalks: "Behold, I am sending you like sheep in the midst of wolves; so be shrewd as serpents and simple as doves." (Matthew 10:16) St. Paul's words also apply: "For God did not give us a spirit of cowardice but rather of power and love and self-control." (2 Timothy 1:7)

Rely on God, be wise and be courageous! In the end, the question we need to ask ourselves is whether or not the lives and souls hanging in the balance at abortion mills are worth the (relatively small) risks we sidewalk counselors and prayer supporters take on. Yes, they are!

Extreme pressure to have an abortion can be put on a young single mother of three who just discovers that she is pregnant. It comes from the father of the baby, his family members, friends, and acquaintances. Many voices surround her with advice and discouraging words, telling her to get rid of it and even suggesting to her an at-home "remedy" using large doses of cinnamon to cause a miscarriage.

So it was with my granddaughter Brittany to the point that she called me in tears. "Grandma, I'm pregnant and I'm going to have to have an abortion. I can't have another baby." My heart dropped as I heard those words and I began to pray for wisdom to help her in this dilemma. "Honey, you don't want to live the rest of your life knowing you killed your own baby and have innocent blood on your hands."

"But Grandma, I can't do it, it's too

hard and I don't have enough support." "We will help you Brittany; we will support you." But she continued to tell me she just couldn't do it and all the people were telling her to get an abortion: the father, his stepdad and others.

As I continued to pray for help from above and to deliver Brittany from this disaster, I said, "Brittany, what will you say to God about what you did to this baby when you stand before Him in the judgement?" She answered, "I don't think there is a God, Grandma, I just don't see it." I answered, "That's because you have turned your back on Him. Turn around and look, you will see Him!"

There was no real answer from her to that. But it came to my mind to bring personhood to this child, so I continued, "Brittany, I believe you have a little girl and I'm going to name her right now. You don't have to name her this, but I want to name her Mercy Joy — Mercy, because God is merciful to give you this baby, and Joy because she will bring you so much joy."

Brittany laughed and asked, "How do you know it's a girl?" I just answered, "Oh I don't know, but I just think it is and want to name her." Somewhere our conversation ended and I still didn't know where she stood in her decision. I asked several people to pray for her.

Just half a week later, I got a call from Brittany. She was crying and said, "Grandma, I'm so sacred. I saw the doctor and they said I'm high-risk. The midwife told me that because its my fourth baby and C-section, that the baby would probably die and I could die. She told me

I should terminate this pregnancy and she knew of a place that would do it and could arrange it for me."

My heart sank again, how could this be? I asked her to wait a day and let me get a pro-life doctor to ask him about it. I sent an email to one of the pro-life doctors we know, explaining the situation. He called me the very next morning and said that there was no way they could determine this as a high-risk pregnancy when she was only eight weeks along, and gave me the name of a good pro-life doctor, Dr. Nicole Seacott.

I quickly let Brittany know this and offered to go with her to every appointment that I could, as a support to her. Brittany was grateful and commented on how afraid she was. We saw Dr. Seacott and Brittany was fine. There was no record in her charts of a high-risk pregnancy. Brittany told her of the midwife. A letter from Essentia Health was sent to Brittany letting her know that the midwife was no longer working there.

A week after the scare from the midwife, Brittany called, "Grandma, if this baby is a girl I'm going to name her Mercy Joy because God is merciful to give me this baby and for the joy she will bring me." Then in tears she said, "Grandma, I'm so glad you are my grandma, because I am going to have this baby and I'm so happy about it."

We had a girl baby shower for Brittany since a ultrasound tech told her it was probably a girl. But a day after the shower Brittany called and said, "Grandma, it's a boy!"

Brittany was very happy to have a boy and decided to name him Malachi Judah. She said Judah means praise God and she praises God because so many people wanted this baby dead, even herself for a moment, but God saved his life!

Malachi Judah was born August 17, 2022, at 8:48 a.m. Everything with the C-section went perfectly well. God answered prayer and he is a beautiful baby boy.

"Who is this little child?" I ask myself. Even the day before the birth we went through a very difficult family trial, which we could identify as a satanic attack. The enemy didn't "get" this one and is angry. Please keep this little boy in prayer.

Current Needs on the Sidewalks in the Twin Cities

The first time I attended a sidewalk counseling training, I did not think sidewalk counseling was for me. I felt like Moses when he said, "If you please, my Lord, I have never been eloquent, neither in the past nor now that you have spoken with your servant; but I am slow of speech and tongue" (Exodus 4:10). I was afraid that if I tried to talk to an abortionminded mother and messed up and she had the abortion, I would be responsible for that child's death, especially if there was anyone more experienced who could have talked to her. But that fear was a lie meant to paralyze me from doing God's work.

We are not responsible for the abortions that happen when we sidewalk counsel! An imperfect sidewalk counselor is infinitely better than no sidewalk counselor, and God works through earthen vessels: "For the sake of Christ, then, I am content with weaknesses, insults, hardships, persecutions, and calamities; for when I am weak, then I am strong" (2 Cor 12:10). After more formal training with Pro-Life Action Ministries, I became a substitute sidewalk counselor. Now, though I still struggle to find the right words sometimes, I work full time in the ministry, and saved a baby simply by encouraging the mother to read our brochure.

We still need more help to ensure no mother goes into an abortion mill without a last minute offer of help and a witness to the humanity of her child. Nearly every day in the Twin Cities, about 30 babies are scheduled to be killed in the area's five abortion centers.

The good news is that, by the end of the summer, we reached about 97% of minimum coverage: the minimum number of sidewalk counselors we need for the minimum range of hours necessary to reach every potential abortion client.

The bad news is that minimum coverage falls very short of the coverage we need to best reach abortion-bound parents, and even the coverage we do achieve relies heavily on substitute sidewalk counselors. This past September, over half of our sidewalk counseling sub

requests went unfilled. Although that is not unusual, and we did generally cover the most critical shifts, we still want to ensure every sidewalk counselor has a partner (we don't require anyone to sidewalk counsel alone) - and at some locations two partners – and that parents leaving the abortion mill toward the end of the day, after taking the first abortion pill, hear from sidewalk counselors about abortion pill reversal. Also, nearly half of the sub requests we filled were covered by the same five volunteers, even though 250 volunteers receive sub request emails! Of course, some of you have much more time and flexibility than others, but I encourage you all to read these emails and come when you can many hands make light work!

We especially need help at the Uptown Planned Parenthood (Mondays and Thursdays) to have three sidewalk counselors at all times. Churches and pro-life groups, especially in South Minneapolis, Bloomington, and Richfield, should consider sending a regular prayer group to Uptown, where we currently have no prayer support, which would dramatically improve the atmosphere for our sidewalk counselors. We need volunteers to overcome their fears of Uptown: we have male and female sidewalk counselors at Uptown, ranging from college students to volunteers over 60 years old - if they can do that, you can at least come pray! At Whole Woman's in Bloomington, all our sidewalk counselors are women who usually do not have men present with them even as prayer supporters, and sometimes

face hostility from nearby businesses. At Planned Parenthood on Vandalia in St. Paul, we are looking for sidewalk counselors in the late afternoons to promote abortion pill reversal to those leaving.

As you discern your role in the pro-life movement, please consider challenging yourself to take the next step:

- Become a prayer supporter: if you have not already, join the over 250 volunteers who pray or sidewalk counsel monthly or weekly outside an abortion location in the Twin Cities.
- Already a regular prayer supporter? Consider becoming a sidewalk counselor and taking a shift or volunteering to sidewalk counsel during your prayer shift whenever one of the sidewalk counselors is gone.
- Already an active sidewalk counselor? Please read the sidewalk counselor Sub Needs emails (sent by thomas.wilkin @plam.org) and fill in when you can. Consider taking a regular shift if you have not already.
- Already a regular sidewalk counselor? Consider doing a monthly shift in addition to your weekly shift, or coming weekly at your monthly time.

Finally, here's some words of encouragement from some of our volunteers:

"You know, after three [or] four times of

MOMS Defend Pro-Life Regulations when A.G. Ellison Fails to Act

Shortly after the U.S. Supreme Court struck down *Roe v. Wade* in the *Dobbs* decision, nearly all of Minnesota's prolife regulations (enacted by the bipartisan state legislature over the past 30 years) were struck down July 11 by Ramsey County District Judge Thomas Gilligan.

The judge struck down:

- Parental notification of a minor's intent to abort
- An informed consent law that gave women accurate information about fetal development, abortion procedures, complications, and long-term effects of abortion
- A mandatory 24-hour reflection period after receiving the information before an abortion could be committed
- A requirement that only licensed physicians could commit abortions and that late-term abortions be done in hospitals

So right now, a 13-year-old can call an abortion mill in Minnesota, get in for an abortion that day if an appointment is available and have an abortion by a nonphysician, paid for by the taxpayers of Minnesota, without even one parent knowing.

Pro-abortion Minnesota Attorney General Keith Ellison chose to ignore his constitutional duty by refusing to appeal

the decision, so a group of about 50 Minnesota mothers of minor girls was formed to file a motion to intervene in the case. The name of the group is MOMS (Mothers Offering Maternal Support). Lead Attorney Teresa Collett and several of the mothers spoke at a Sept. 13 press conference which can be viewed here: www.youtube.com/watch?v=IddmHVdp g-E

Attorney Collett said Ellison had three years to present evidence challenging the claims of the plaintiffs and failed to do so. But in 43 days, her clients gathered evidence from "11 of the nation's experts contesting virtually every fact that the

judge's ruling was based on."

"We are uplifted that something is being done to fight Gilligan's decision," said Brian Gibson, Executive Director of Pro-Life Action Ministries, which helped behind the scenes to manage the creation of the MOMS group.

Collett said she is optimistic Gilligan will grant their motion to intervene and believes it will have a chance at success because her clients are "the real people who will be harmed" because of this decision.

Is *Your* Doctor Involved in Abortions?

Does Your Doctor Prescribe Abortifacient Birth Control?

Ask your doctor if he/she does abortions or refers for them, or prescribes abortifacients such as the Pill, Ortho Evra (the "patch"), Depo-Provera (the "shot"), Nuva-Ring, the "morning-after pill," implants, or the IUD. All these methods (and others) can cause very early abortions by thinning the lining of the uterus so that if breakthrough ovulation occurs (which is possible) and a new life is conceived, the young human being may not be able to attach to the uterine lining and therefore he or she dies. 
