PP Stripped of Federal Medicaid Funds for One Year

After decades of work by pro-lifers, Planned Parenthood (PP) has, for the first time, been stripped of federal Medicaid funds (for one year). This is a victory for unborn babies as pro-lifers continue to work to make this defunding permanent.

In early July, Congress passed and Pres. Donald Trump signed into law the "One Big Beautiful Bill" which, among other things, stops federal Medicaid reimbursements to PP. Although PP immediately sued in a federal district court in Massachusetts and obtained an injunction against the law, the Trump Administration is appealing that injunction. Meanwhile, PP North Central States (covering



This seven-story, 78,000-square-foot Planned Parenthood facility in Houston, Texas, once the largest abortion mill in the country, is just one of 41 PP facilities this year which have closed or announced their upcoming closures. Opening in 2010, this mill killed up to 10,000 babies a year (up to 24 weeks), according to Shawn Carney, CEO of 40 Days for Life, based in Bryan, Texas. This PP stopped killing after Texas banned abortions in 2022. Prior to that, the Texas Legislature had cut off funding for PP and other abortion providers in 2011. It also barred PP from its Medicaid program in 2021 after a legal battle, and in 2019, the Legislature had prohibited local governments from contracting with PP.

Minnesota, the Dakotas, Iowa and Nebraska) states on its website that "President Trump and Congress passed a law blocking Medicaid patients from care at Planned Parenthood. We are committed to working with every patient to access the care they need." In a July 16 fundraiser, PPNCS wrote, "The loss of Medicaid funds leaves us with a potential staggering financial gap of almost \$11 million to fill."

However, PP could continue being reimbursed for Medicaid patients if it simply stopped aborting babies! But apparently, killing 402,230 preborn children in service year 2022-2023 was too profitable for them to quit.

This in not a complete defunding of PP. There are other smaller federal tax-funded grants as well as state and local tax dollars doled out to the abortion giant. But this is a very significant portion of

income for PP. Medicaid reimbursements are by far PP's largest federal tax-funding source, amounting to about \$500 million per year. (In fiscal year 2023-2024, PP received nearly \$800 million in total federal, state and local taxpayer funding.)

Tragically, due to the 1995 *Doe v. Gomez* decision by the Minnesota Supreme Court, taxpayers in the state are required to pay for abortions for women on Medical Assistance (MA). There is even a loophole in the law, exploited by the abortion industry, which allows certain single pregnant women without other children to sign up for MA (because now she counts as a "family of two") and then she can use that MA funding to abort that family member! Of interest to readers connected with our Central Florida branch, PP of Florida on its website

states, "A new law blocks patients with Medicaid from using their insurance to pay for the care they get at Planned Parenthood health centers."

Pro-Life Win in U.S. Supreme Court

In related good news, on June 26, the U.S. Supreme Court, by a 6-3 vote, upheld South Carolina's right to exclude Planned Parenthood and other abortion providers from its Medicaid program. (Medina v. Planned Parenthood South Atlantic) According to court documents, the state has "140 federally qualified health clinics and pregnancy centers, not counting the numerous private health providers who accept Medicaid."

John Bursch, Alliance Defending Freedom Senior Counsel, who argued before the Supreme Court, said, "The American people don't want their tax dollars propping up the abortion industry. The Supreme Court rightly restored the ability of states like South Carolina to steward limited public resources to best serve their citizens."

This decision allows other states to restrict their Medicaid program to businesses that do not commit abortions. This would prevent evil schemes like one being instituted by the Whole Woman's abortion chain, which announced the day after the *Medina* decision: "In Virginia, we currently accept Medicaid for nonabortion OB/GYN care, and we're preparing to start billing Medicaid for abortion-adjacent services—like ultrasounds and office visits (emphasis added) —so patients with Medicaid can receive a discount on the cost of their abortion care."

security" wearing vests or smocks. These stand on the property of the abortion facility (and sometimes in the public areas) to directly block our written and oral messages, denying the young women and those who may accompany them the opportunity to decide for themselves whether to accept our help. In at least one location, a dozen or more show up each week to drown out the life-saving messages from the sidewalk counselors.

Additionally, there are a handful of those who usually claim not to be associated with the abortion facility (but are encouraged and supported by the facility

Man who Attacked Elderly Pro-Lifers in Baltimore Gets Light Sentence

A man who violently attacked two elderly pro-lifers in Baltimore two years ago recently received a light sentence, with no jail time. Patrick Brice, 28, had been convicted by a jury of two counts of second-degree assault and two counts of reckless endangerment.

The crimes occurred in May 2023, when Brice, a passerby outside the Baltimore Planned Parenthood, got into a brief, loud discussion with sidewalk counselor Dick Schaefer, then 84. A surveillance video shows that Brice seemed to be leaving, but then he tackled Dick into a large planter and wall, causing hand, shoulder, head, and back injuries.

As prayer supporter Mark Crosby, then 73, went running to assist Dick, he was knocked to the ground by Brice, who then brutally punched and kicked him in the face. Along with other injuries, Mark's right orbital bone was fractured and he had bleeding behind that eye. He spent three days in the hospital and has lasting hearing and vision problems.

"Shedding blood and suffering pain for Jesus was the most powerful spiritual thing that has ever happened," Mark told the *Catholic Review*. "It was a gift." He and Dick returned to the sidewalk less than a week after the attack to continue their almost-daily pro-life ministry.

The jury was undecided about a felony charge of first-degree assault in Mark's case. During a re-trial of that charge,

Judge Yvette M. Bryant acquitted Brice because she said he didn't intend to do serious harm (as the law requires). Although prosecutors were asking for a 10-year prison sentence on the other charges, Bryant only sentenced Brice to a year of home detention, three years of probation, and orders to complete anger management classes, undergo drug and alcohol screening, and remain in therapy.

Tom Brejcha, Founder and President of the Thomas More Society, said, "Justice was not served in this case, and we must continue to fight until all peaceful pro-life voices are protected."

In the June issue of *Pro-Life Action News*, we included a quote from Planned Parenthood DIRECT, PP's mail-order abortion pill website: "If medically necessary, in-clinic follow-up care may be available." 'Early Abortion' Not Synonymous with Safety

On June 14, an emergency was reported at the East Orlando Planned Parenthood. Operation Rescue staff secured the actual 911 records related to this emergency involving a woman who had a suspected lidocaine toxicity likely following an abortion procedure. Although the type of abortion procedure was not disclosed, the caller reported a woman experiencing symptoms of "lidocaine toxicity." Lidocaine is an anesthetic often used to numb the cervix during something like an aspiration abortion, which this facility offers up to six weeks.

Lidocaine toxicity is a serious medical condition that can occur when excessive amounts of this drug enter the bloodstream, potentially affecting the central nervous system and cardiovascular functions. Symptoms can range from dizziness and confusion to seizures, respiratory depression and cardiac arrest. Fast recognition and medical intervention are critical to prevent life-threatening outcomes.

Troy Newman, President of Operation Rescue, comments, "This alarming case highlights the inherent dangers associated with abortion procedures, even those occurring early in pregnancy. A smaller window of time to abort is certainly saving preborn lives in Florida but the abortion cartel continues to operate and we still see dangerous complications arise. 'Early abortion' is not synonymous with safety. Restricting abortion is not enough. We must abolish abortion."

Joseph Nelson

Joseph Nelson, 39, is an abortionist at Whole Woman's in Bloomington, Minn. He was an abortionist in Texas, but when that state banned abortions in 2022, Nelson moved to Minnesota. (Whole Woman's is an abortion chain begun by a Minnesota woman, Amy Hagstrom Miller, which had to close several abortion mills in Texas.)

In January 2023, Nelson testified in a Minnesota House committee, promoting a pro-abortion bill that shields abortionists in Minnesota from laws in pro-life states when committing abortions on out-of-state women. This was one of several terrible pro-abortion bills that were passed by the Democrat-controlled legislature that year.

In his Twitter profile in 2019, Nelson described himself as "Your friendly neighborhood abortion provider." When asked in a 2020 interview what inspired him to become a doctor, Nelson stated that his father "is a biomedical engineer, and his enthusiasm for the wonder of the human body in particular always affected me." Please pray that Nelson would see the sacredness of the human person, stop basing his medical career on the killing of unborn children, and would repent and turn to Christ.

Is Your Doctor Involved in Abortions? Does Your Doctor Prescribe Abortifacient Birth Control?

Ask your doctor if he/she does abortions (especially with the current increase and "ease" of prescribing the abortion pill) or refers for them, or prescribes abortifacients such as the Pill, Ortho Evra (the "patch"), Depo-Provera (the "shot"), Nuva-Ring, the "morningafter pill," implants, or the IUD. All these methods (and others) can cause very early abortions by thinning the lining of the uterus so that if breakthrough ovulation occurs (which is possible) and a new life is conceived, the young human being may not be able to attach to the uterine lining and therefore he or she dies. This young mom, who had been so pressured, was resolute in her decision to protect her child after finding out that there truly were people who would help her out on this journey. We are keeping in touch, and already have a baby shower planned.


