sense, she has seen it all and her review of her visit to the Twin Cities was surprising, yet spot on. Even though our 40 Days for Life numbers are down this



# Banquet Features Pardoned Pro-Life Activist, Paul Vaughn

Thank you to all who attended our Life Banquet on October 6! A beautiful autumn evening welcomed our guests to the Heritage Center to celebrate our accomplishments and renew our mission to stop abortion, one life at a time.

Our emcee, Gary Gillet, Sidewalk Counseling Manager, led us through our program which included Baby Saved testimonials from sidewalk counselors Mary Kay and Evie, a Baby Saved story from a mother in partnership with a local pregnancy help center, our Ministry Update given by Brian Gibson, CEO, and finally, our Keynote Speaker, Paul Vaughn.

Paul humbly shared the details of his unjust prosecution by the Biden Department of Justice for praying and singing in



the hallway outside a Tennessee abortion facility while others peacefully sat in front of the abortion mill doors to prevent babies from being killed. We learned that his ordeal, which included being arrested by the FBI at gunpoint at home in front of his wife and some of their 11 children, was an intentional attempt to silence prolifers and invoke fear by misusing a law from the 1800's. He was convicted and sentenced to 6 months of house arrest and 3 years of probation, having faced a potential sentence of 11 years. Paul was then one of the 23 peaceful pro-life activists pardoned by Pres. Donald Trump.

# From the CEO, Brian Gibson . . .

### Let us Persevere

The summer of 2025 was a very difficult one with several shocking events, two of which were in the Twin Cities metro area of Minnesota. The first were the assassinations of Minnesota Rep. Melissa Hortman and her husband Mark and the attempted assassinations of Minnesota Sen. John Hoffman and his wife Yvette. Very early in the subsequent manhunt, the assassin was identified as being "pro-life." Since Rep. Hortman and Sen. Hoffman were both pro-abortion politicians, the media speculation was that these horrific attacks were somehow caused by the assassin's beliefs or the pro-life movement as a whole. We were dealing with the duality of the tragedy and possible media attacks. The first part never abated, the second was calmed after written ramblings of the shooter were discovered.

Then came a greater shock, the shooting at Annunciation Church during a worship service, targeting school children at that service. Two children were killed, a third, Sophia, was seriously injured (for whom we continue to pray), and another 26 school children and three elderly people were injured. Many supporters and volunteers of our ministry either belong to this church or have family members who belong. At least one of those in attendance during the shooting is a very active volunteer with our ministry.

And then, two weeks later came the Charlie Kirk assassination.

The senseless loss of life in each of these grieve us deeply. One may impact us more than another, but none of these should have happened. Part of the difficulty of all these is the relentless news cycles that came with each one, flooding our senses with details and speculation we simply don't need. And which can cause us to give pause to our dedication to our work on the streets and in proclaiming the pro-life message.

In the Book of Hebrews, it states:

Therefore, since we are surrounded by so great a cloud of witnesses, let us also lay aside every weight, and sin which clings so closely, and let us run with perseverance the race that is set before us, looking to Jesus the pioneer and perfecter of our faith, who for the joy that was set before him endured the cross, despising the shame, and is seated at the right hand of the throne of God.

Consider him who endured from sinners such hostility against himself, so that you may not grow weary or fainthearted.

Therefore, lift your drooping hands and strengthen your weak knees, and make straight paths for your feet, so that what is lame may not be put out of joint but rather be healed. Strive for peace

### Recent Activities in Moorhead and Central Florida

#### Life Runners and 40 Days

The Moorhead, Minn. affiliate of Pro-Life Action Ministries participated in the 2025 Life Runners A-Cross America Relay by hosting the kick-off of the north arm of the relay September 20. About 50 people met in front of the Cathedral of St. Mary in Fargo, N.D., then walked 2.7 miles to the Red River Women's abortion facility in Moorhead carrying a banner proclaiming "Remember the Unborn." The event started with prayers and cheers for life. It was met with noise and scantily clad clowns trying to distract the people praying with crude conversations and other distractions. With the help of the Holy Spirit, we were able to stay calm, with our eyes cast down, our minds filled with prayers both for the babies that are scheduled to die at the facility and for the counterprotesters that they can find Jesus.

A few days later, on September 24, we had our 40 Days for Life opening. The pro-abortion escorts sneaked in late the previous night and parked their cars where we were planning to park our trailer, so we had to improvise a bit and have

our trailer on the side street. So about half of our group stayed in front of the abortion facility offering help to women, while listening from a distance to the speakers, and the other half stayed nearer to the trailer. Easton T. talked about one of his experiences sidewalk counseling a family in which the dad came around and wanted the baby, but the mom still didn't. Then

# On the Front Lines

Editor's note — The Duluth, Minn. abortion facility, WE Health, typically kills babies one day a week. For years, the stalwart sidewalk counselors and prayer supporters there have had to contend with a dozen or more escorts on every killing day. Please pray for the very dedicated pro-life activists in Duluth. Despite all this opposition, they have saved lives on the sidewalk! The following article is reprinted from the September issue of the Pro-Life Ministries of Duluth newsletter.)

The atmosphere at the abortion center often feels oppressive. The escorts come out, turn on their pornographic music, put up their rainbow-colored banners, and open their umbrellas. They use umbrellas to block us from giving material to the moms going into the abortion center. It's absurd that they should have such zeal and aggression just to keep us from giving informative material to the moms, especially since their mantra is "prochoice."

One Thursday morning when the abortion center was open for business, we noticed a St. Louis County car parked a bit down the road. Two women came out of the car; one was a young woman, the other was the driver of the car. They both went into the abortion center.

A little bit later they walked out and the young woman was carrying the abor-



All year long and in all kinds of weather, pro-abortion escorts in Duluth hold umbrellas just waiting for the moment when an abortion client comes so they can open the umbrellas to block the sidewalk counselors. They have also added another strategy to thwart the life-saving efforts of the sidewalk counselors: several escorts encircle and hold hands around the abortion client as they walk her in.

tion pill bag. I followed them to offer material to the young mom. An escort was in front of me with her umbrella to stop me. When I asked the young mom if I could give her some helpful material, the woman who was the driver of the St. Louis County car yelled a firm "No." The escort told the young woman, "You don't have to take anything from her," and continued trying to block me. But I saw an opening as she went into the car; the window was open a bit. I said, "Here, you want this." She took the material and I said, "Don't let anyone take this from you. I'm here to help you. Please go to abortionpillreversal.com. You can reverse this. We want to help you. Call me." She made eye contact with me and I saw a very scared young woman. As I felt my heart breaking for her, I told her to call me, and she said, "Okay." I haven't heard from her, but I'm praying. Please pray for her as well.

Psalm 127:3: "Behold, children are a heritage from the LORD, The fruit of the womb is a reward." This scripture is what God intends for mankind. The joy of children cannot be compared to anything on this earth! Children are a great blessing! There is a reason God told Adam and Eve, "Be fruitful and multiply!" It brings great glory to God.

The abortion center, WE Health, is housed in the Building for Women. WE Health does "gender-affirming hormone care." Doesn't it make sense that they would offer this? The Building for Women and WE Health do their best to stop children from coming into the world (and we know who is really behind this.)

year, all of us "must keep going," and we are "doing great."

As the former manager of a Planned Parenthood referral facility ("feeder clinic"), it was Ramona's job to get as many women to Planned Parenthood's surgical and abortion pill facilities as possible. She shared during her talks that she had a kind of mental wall between what she was doing and the killing at Planned Parenthood's surgical / pill facilities; she was merely making referrals. After a

series of 40 Days for Life campaigns in Sherman, Texas where she worked, the Holy Spirit convicted Ramona that she was complicit too! Witnessing the peaceful and prayerful demeanor of the 40 Days participants, she left the abortion industry in 2011. Ramona's resignation from Planned Parenthood resulted in her former center going out of business.

Ramona recorded a show with Brian Gibson, CEO of Pro-Life Action Ministries, on Relevant Radio (Brian's show airs every Saturday in the Twin Cities metro area and online, see page 8). Ramona also shared a podcast (Lucky the Educator) with yours truly. What was interesting was that the host wanted to rescind his invitation because Ramona was a former Planned Parenthood facility manager — as far as the podcaster was concerned, a "former baby killer." I reminded him I was on his show more

Besides two documented babies saved so far during our fall 40 Days for Life campaign outside the St. Paul Planned Parenthood, there have been two other women who left, saying they had changed their minds. We don't know specifically what caused their change of heart, but there were people praying on the sidewalk at the time! And there was another hopeful situation in Duluth while 40 Days for Life participants were praying.

### Never Give up Praying!

While ministering at the AWHC abortion facility in late September, I noticed an abortion bound woman walk out. I immediately called out to her, offering help, and urging her to come and speak with me, which she did. I asked if she was there for an abortion and she replied yes, and that this was the first day, and that she would be coming back the following day. (Note -- Florida requires a 24-hour waiting period between the initial in-person "consultation" and the abortion itself.)

I pleaded with her to reconsider this decision. I could see tears coming into her eyes, and she said, "I'm so confused and really don't want to do this, but I already have three children." I then told her that we would love to take her out to lunch and help her anyway that we could. She shared what area of town she lived in and I gave her information on a great pregnancy resource center in her area. She immediately looked at me and said that she had already been there before in the past and that maybe she would go there on her way home. I encouraged her to do so, then exchanged phone numbers with plans to get together. I was hopeful that she wouldn't go through with the abortion.

Unfortunately, I tried calling her several times throughout the next couple weeks, but there was no answer or response. Until yesterday when I received this text, "No, I didn't go back. It's O---! I'm at the pregnancy center, finally able, and just walking in!"

Oh, I was so thankful, after continuing to pray for this woman and protection for her baby, to hear two weeks later that her child was still alive, and she was letting me know she didn't go back! Once again, it is a strong reminder that we must never give up praying and crying out to God! I praise HIM, and look forward to walking along and helping another woman through her journey of choosing life for her baby. Hallelujah, HE is great and greatly to be praised!

#### The Power of our Literature!

In mid-September, a woman went to the Brooklyn Park Planned Parenthood (PP) for an abortion. The sidewalk counselor gave her our literature on the way in. She was allowed to see her ultrasound which showed she was five weeks along. After the ultrasound, she got the information about the abortion pill, but walked out of that meeting, telling the PP employee she didn't want the abortion.

But reading about all the help available gave her the ability to say no to the abortion and walk out. Praise God for her courage and strength. The sidewalk counselor has remained in touch with her, helping her in practical ways. This mom is also in contact with a pregnancy help center which is helping her with additional resources.

than twice and that my wife (then fianceé) and I killed our child about 44 years ago and the only difference between Ramona and me were the number of children, and that Ramona and I have repented and been covered by the blood of Jesus Christ.

At a meeting hosted by the Minnesota Family Council and attended by the Minnesota Catholic Conference, Minnesota Citizens Concerned for Life, Midwest Students for Life and True North Legal, Ramona revealed the inner workings of an abortion facility and the mindset of its workers. Later she spoke after an all-Spanish mass at St. Frances de Sales. She shared her testimony of how God pulled her out of the abortion industry.

These three abortionists are no longer licensed to practice medicine in Minnesota so we are removing them from the Minnesota list below. Before doing so, however, we ask that you continue to pray for their repentance and conversion to Christ.

Carol Ball is the former Medical Director of the five-state Planned Parenthood affiliate based in St. Paul. Besides committing abortions at that location, she also killed in Duluth and Sioux Falls and in the former abortion facility at Regions Hospital.

Melvin Frisch committed abortions (along with his daughter Hope) at the former Meadowbrook abortion facility before it was bought by Whole Woman's in late 2012. He was licensed in the state of Arizona in 2008 (license still active), and according to www.abortiondocs.org (produced by Operation Rescue), he has worked at various Planned Parenthood locations in Arizona.

Timothy O. Olson committed abortions at the Mayo Clinic in Rochester, Minn. Please pray that all three of these physicians would repent of committing abortions and never again take the lives of innocent children.

# Is Your Doctor Involved in Abortions? Does Your Doctor Prescribe Abortifacient Birth Control?

Ask your doctor if he/she does abortions (especially with the current increase and "ease" of prescribing the abortion pill) or refers for them, or prescribes abortifacients such as the Pill, Ortho Evra (the "patch"), Depo-Provera (the "shot"), Nuva-Ring, the "morningafter pill," implants, or the IUD. All these methods (and others) can cause very early abortions by thinning the lining of the uterus so that if breakthrough ovulation occurs (which is possible) and a new life is conceived, the young human being may not be able to attach to the uterine lining and therefore he or she dies. ### Bishops, Other Pro-Life Leaders Denounce Trump's New IVF Policy

The bishops who chair key committees for the United States Conference of Catholic Bishops (USCCB) and other pro-life leaders denounced the Trump Administration's new initiatives expanding access to in-vitro fertilization (IVF).

"Though we are grateful that aspects of the Administration's policies intend to include comprehensive and holistic restorative reproductive medicine, which can help ethically to address infertility and its underlying causes, we strongly reject the promotion of procedures like IVF that instead freeze or destroy precious human beings and treat them like property," Bishops Robert Barron, Kevin Rhoades, and Daniel Thomas said in the joint October 17 USCCB statement.

Kristan Hawkins, President of Students for Life of America, said, "I'm thankful there's no new healthcare mandate forcing coverage for the destructive IVF industry, but IVF, as it's practiced, still destroys countless humans in the embryonic stage. It's time to find real solutions that help families grow and flourish without killing life in the process."

#### **Update on PP Funding**

In the last newsletter, we reported that Planned Parenthood (PP) had received a temporary restraining order July 7 against the new law which stops federal Medicaid reimbursements to PP and certain other major abortion providers for one year. The First Circuit Court of Appeals recently lifted this injunction so PP is currently banned from receiving federal Medicaid funds while its lawsuit proceeds.
